Revision of rate of Interest on Deposits:-<u>Effective from Feb 08, 2021</u>

In view of revision of Rate of Interest on Deposits by Public Sector Banks and Co-operative Banks and taking market situation in consideration, it is felt urgent to revise the rate structure and accordingly, the revised rate of Deposits with effect from Feb 08, 2021 are as follows:-

	(b) The rate of interest of Pledged Loans against Govt. Security (NSC, KVP etc.) and Surrender value of LIC; will be at least applicable rate of interest on Farm Loan to ultimate borrowers on Quarterly Compounding Basis.	

It is advised that in case of any sort of term deposit/re-investment plan scheme the interest is to be calculated on Quarterly Compounding Basis.

This circular supersedes the previous Circular no 1712 (Pt-I)/Oprn./70 (30) dated May 30, 2020 of this Bank.
