## NOTICE INVITING QUOTATION

Sealed quotations of rates are invited from PWD enlisted Contractors or authorized/bonafide Electrical Agency / outsiders having adequate experience for Dehydration & Filtration of Transformer Oil for 400 KVA Transformer, Potential Transformer, Oil Circuit Breaker of H.T. Switchgear and Servicing & Overhauling of L.T. Panel Board and 200 KVA Generator Panel Board etc. of the Electrical Sub-Station at ICMARD Building at Block – 14/2, CIT Scheme – VIII (M), Ultadanga, Kolkata – 700067 as per Technical Specifications described in ANNEXURE – I (enclosed herewith) along with the necessary details and Terms & Conditions given hereunder:-

1. The intending tenderers/bidders should have Supervisor's Certificate of competency issued by the Director of Electricity, Govt. of West Bengal and should furnish their Telephone Numbers (both land and mobile) for quick and urgent communication.
2. The quoted rates should be inclusive of prevailing GST etc. and other incidental charges and the rate should be quoted in figures as well as in words.
3. The bidder must furnish copy of PAN/TAN & GST Registration Certificate with the bid.
4. The tenderers/bidders may visit the Electrical Sub-Station of ICMARD Building with a prior intimation to ICMARD, before submission of their quotations.
5. The scope of work comprises dehydration and filtration of sub-station equipments/installation and change of silica gel of breather of Transformer and H.T. Switchgear etc.
6. The quotation should be valid for at least 03 (Three) months from the last date of submission.
7. A test report have to be submitted of Acidity & Breakdown Voltage of the Transformer Oil through a reputed analytical chemist after execution of dehydration & filtration work. Sample of oil shall have to be taken from each equipment separately and for which separate test report shall be submitted.
8. New transformer oil of approved grade only should be supplied if required.
9. Time for completion of the whole work will be 15 (Fifteen) days from the date of issue of the work order.
10. Tools, tackles and all allied instruments for the work shall be arranged by the contractor at his cost.
11. The sealed cover quotation should be superscribed as **"Quotation for dehydration, filtration & other Electrical Maintenance Work of Electrical Sub-Station of ICMARD Building"** and the quotation in own letter head, complete in all aspect, must reach to the Principal, ICMARD under sealed cover latest by **May 17, 2025**.
12. The authority do not bind themselves to accept the lowest quotation & reserve the right to accept any quotation and also reserve the right to reject any or all the quotation(s) without assigning any reason thereof.
13. Payment will be released after completion of the work subjected to satisfaction and against submission of Bills in duplicate. No advance payment would be done before completion of the work.
14. The bidder must furnish the GSTIN and PAN/TAN along with the Bank Account Details. Payment would be released after **applicable Tax Deductions** on the billed value.
15. Payment would be released only in online mode through RTGS/NEFT transfer.


