Scope of Work:

The successful Bidder [hereinafter referred to as the Vendor] has to supply and install the Split Air Conditioning Machines, interconnect the Indoor and Outdoor Unit with suitable Electrical Cable & Refrigeration Pipes [Beyond 3.0 Meters] including supply & fixing of wrapping tape as required, supply & fix Outdoor Unit Stands, supply & fix the Water Pipe of Indoor Unit with saddles on wall at Ground Floor and 2nd Floor of Purulia District Office Building of The WBSCARD Bank Ltd. **in case of Purulia District Office Building** and has to supply and install the Window Air Conditioning Machines and Wooden frame with plywood boxing for installation of the said AC Machines at 1st & 2nd Floor respectively of ICMARD Building of The WBSCARD Bank Ltd. **in case of ICMARD** and also has to provide on-site Comprehensive Warranty support for 1 year from the date of installation. The Air Conditioning Machines & other accessories should confirm to the detailed technical specifications mentioned in Annexure-I & Annexure – II respectively. Warranty Support should be provided directly by the Original Equipment Manufacturer (OEM).

Tender Validity:

- a) The Tender shall be valid for a period of **90 days** from the last date of submission of Tenders;
- b) In exceptional circumstances, The WBSCARD Bank Ltd. may solicit the Bidder's consent for extension of the Bid Validity Period. The request and the responses shall be made in writing. When the validity period is extended by the Bidder, the same is to be done without any modification to the Bid proposal by the Bidder;
- c) All prices quoted must be firm and valid during bid validity period and extended periods, if any. All prices quoted shall not be affected by any escalation in prices of labour or materials, machineries, equipment etc. or in rupee exchange rate during the Bid Validity Period whatsoever.

Eligibility Criteria for Participation in the Tender:

1. Bidder should be Profit making Company for consecutive last 3 years.
2. The Bidder should preferably be a Company/Firm/OEM for last 05 years and should have Service Centre with Call Logging Facility at Kolkata & Purulia. Supporting documents for existence of Service Centre with phone numbers have to be attached.
3. The Bidder shall be required to give a **Declaration** in their Letter Head that it has not ever been banned by any Govt. Agency/ Govt. Deptt., Semi-Govt./Quasi-Govt. Deptt./ PSU/ Board/ Council or if similar Organizations had banned the Bidder and later on had lifted the ban, the fact must clearly be stated.
4. Declaration should be submitted in Bidder's own Letter Head stating that no refurbished components have been used in Air Conditioning Machines.
5. Quoted Model technical datasheet should be available in OEM website, Product Model Number and Warranty information should also be available in Public Domain.
6. Bidder should preferably have executed at least 2 similar works involving supply and installation of Air Conditioning Machines at any Govt. Deptt./Quasi-Govt. Deptt./ PSU/ Board/ Council or similar Organization during the last two Financial Years.
7. The Bidder should have positive Net Worth for the last three years.
8. Offline submission of Tender documents will not be accepted, in any circumstances.

2. The Financial Bid should be inclusive of all taxes, levies, cost of freight, delivery and installation charges etc. The WBSCARD Bank Ltd. will not pay any Delivery/ Installation charges separately for supply of the said accessories at location mentioned in **Brief Description of Assignment** above.

3. Technical Bid containing the details of eligibility criteria shall have to be submitted separately.

(B) Bid Evaluation Process:

1. Compliance against Eligibility Criteria

The Technical Cell of The WBSCARD Bank Ltd. will decide whether the Bidder's response satisfies the stated eligibility criteria specified in the Tender Documents. Any shortcomings or deficiencies [including omissions & variations] will be recorded. If any Bid does not satisfy the eligibility criteria, it shall be rejected and cannot be made eligible by correction or amendment. Once the examination of the Technical Bids are completed, the Financial Bids of only those Bidders whose Technical Bids are acceptable, will be opened and uploaded in the e-Tender Portal of the GoWB.

2. Examination of Short-listed Financial Bids

i) The WBSCARD Bank Ltd. will determine whether the Financial Bids, opened, are complete, i.e. whether the Bidder has included all components as per the Tender Document. If not, The WBSCARD Bank Ltd. may reject the Bid as non-responsive.

ii) Financial Bids shall be compared for the complete Scope of Work as per the Price Proposal Schedule inclusive of all taxes and duties. The Price Schedule shall also have the indicative price break-up.

3. Other Terms and Conditions of Tender Documents

1. The successful Bidder will supply and install the Air Conditioning Machines & other accessories as mentioned in **Annexure - I & Annexure - II**;

2. That the vendor will be allowed two (02) weeks time to deliver and install the items at site after official intimation;

3. That the vendor shall pay liquidated damages @ 2% (Two Per Cent) of the total unexecuted contract value per week subject to a maximum of 5% of the unexecuted Contract Value in case of delay of installation as per the time frame indicated above. However, when the amount of the liquidated damages is equivalent to 10% of the Contract Value, The WBSCARD Bank Ltd. will have the discretion to terminate the contract without any further reference;

4. That the Hardware delivered by vendor to the Purchaser must be covered by a On-site Comprehensive Warranty for a minimum period of **One (01) year** on all items from the date of installation.

5. The bidder may visit the site for better understanding of the Scope of Work on any working day of The WBSCARD Bank Ltd. from 12 PM to 4 PM with prior intimation to The WBSCARD Bank Ltd.

6. Deduction @ 5 % (Five Per Cent) would be made from the amount of Bill towards Security Deposit and the said Security Deposit would be retained by The WBSCARD Bank Ltd. for **one (01) year** from the date of installation of the Air Conditioning Machines. The said Security Deposit would accrue no interest.

7. **The Defect Liability Period** : The prevailing rules and norms of the Government of West Bengal under this Clause as in force shall be strictly followed by the selected Bidder/Contractor or his/her/its workmen or authorized representatives and in the event of any loss, breakdown, damage, destruction, injury to lives and property during execution of the work, the selected Bidder/Contractor shall remain solely liable and responsible and will have to make good whatever the compensation at his/her/its own expenses and the cost to be incurred shall be recovered/realized from the amount of Security Deposit lying with the authority of The WBSCARD Bank Ltd. from the Bill of the selected Contractor/Bidder. All risks on account of any incidental events in respect of carriage, loss or damage of vehicles, materials or labours will have to be borne by the selected Bidder/Contractor.
