Notice Inviting Quotation (NIQ): -
Sale of Scrap

Sealed Quotations are invited by the ICMARD of The WBSCARD Bank Ltd. from the bonafide Scrap Vendors for disposal of its obsolete/ scrap items, '**as is where is basis**', located at different places of the ICMARD Building, Block-14/2, C.I.T. Scheme - VIII (M), Ultadanga, Kolkata - 700 067. The intending Parties/ Scrap Venders may inspect the above Site/ Location containing the Scrap Disposable items (as listed & attached herewith) before submitting their Quotations and Rate/Quotation should be submitted for each item separately in the Format specified in **Annexure-I**. The terms & conditions, as specified/appended below should be strictly followed at the time of submission of their quoted rates: -

1. The intending Parties/ Scrap Venders may physically inspect the site/ location for observation of the Scrap materials on any working day from 11 AM to 4 PM up to **August 14, 2026**.
2. The intending Parties/ Scrap Venders would quote/offer items-wise rates/prices for each item as specified in the enclosed **Format (Annexure-I)**. The quantities of disposable/ scrap item as indicated in the **list of Scrap Materials (Annexure-I)** may vary i.e. increase or decrease which would be ascertained/assessed as per actual quantity of materials to be collected pertinent to the said list and as such, the offered rates/prices would be determined proportionately based on the actual quantities of such materials to be received on spot. No Lump Sum Rate over the total/overall items of Scrap materials would be allowed.
3. Successful highest Bidder will have to **deposit the Offer Value at least 3 (Three) days** prior to taking the delivery of the materials.
4. Arrangements for manual labourers or any other items/ services, if necessary, for removing for materials have to be made by the Highest Bidder. The Bank will not be involved in the process of procurement of Labours, Cranes or other machineries by the Highest Bidder and will not bear any cost towards removal of the scrap materials. If the successful Bidder fails to lift the material within 10 days from the date of issue of Sale Order from this end, Storage Charges @ Rs. 1% will be charged up to 10 days after which the Order will be treated as cancelled.
5. The intending Bidders, with due permission, may visit and jointly inspect the site along with the Bank Officials for the scrap materials before quoting the Offer Value.
6. **GST** as per applicable rate will be **recovered separately** by the Bank from the successful Bidder along with Offer Value. This amount will be over and above the Offer Value.
7. The Successful Bidder will have to deposit the Offer Value plus GST either by **NEFT or Demand Draft** drawn in favour of '**The Institute of Cooperative Management for Agriculture & Rural Development**' (ICMARD).
8. On receipt of the entire amount within stipulated time, **Sale Order** will be issued by the Bank Authority to the successful Bidder observing necessary official formalities.
9. The Bid will be awarded to the Highest Bidder based on the highest offered value/ price.
10. The Bank Authority reserves the right to reject any or all the quotations without assigning any reason thereof.

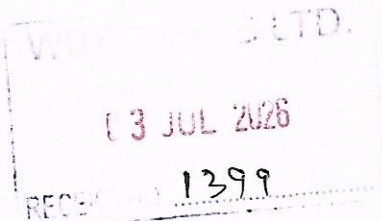
