Sealed Quotations are invited from authorized Service Providers/Agencies for entering into Non-Comprehensive Annual Maintenance Contract for total **04 (Four)** number of **Split AC Machines** and **12 (Twelve)** number of **Window AC Machines** installed at the Head Office and Kolkata Branch of The WBSCARD Bank Ltd. located at 6th Floor and 4th Floor respectively of the ICMARD Building, Block – 14/2, CIT Scheme – VIII (M), Ultadanga, Kolkata – 700067 under the following **terms & conditions:-**

1. The AMC is for an initial period of 12 months and renewable thereafter if the services are found to be satisfactory it can be extended for another 12 months.
2. AMC shall include Servicing of all the AC Machines 4 times throughout the AMC Period (**2 Wet Service & 2 Dry Service**) and extending necessary services/repairing to keep all the AC Machines operative. Under all circumstances, standby arrangement is mandatory.
3. All the **complaints** received from The WBSCARD Bank Ltd. should be attended within the **next working day** failing which shall incur a deduction in the Monthly payment and reputation of such failure, may lead to **termination** of the AMC.
4. If any item is required to be replaced/procured, the same may be done by the Agency with additional cost after obtaining prior approval from the competent authority of The WBSCARD Bank Ltd. In such, case, the items must be procured and replaced within two working days from the date of receipt of approval from the authority of The WBSCARD Bank Ltd.
5. It shall be responsibility of the Selected Service Provider to extend necessary service so as to ensure that all AC Machines work satisfactorily throughout the contract period.
6. The Bidder should have its own Service Providing Office/ Work Shop in Kolkata.
7. The Bidder should posse minimum **01 (One)** year of experience of rendering Comprehensive / Non-Comprehensive / Semi-Comprehensive AMC for the AC Machines in Government Sectors i.e. Central / State Public Sector Undertaking, Autonomous Bodies, renowned Private Sector Offices, Research and Educational Institutions etc.
8. The Quotation must be valid for a period of at least **03 [Three] months** from the last date of submission.
9. The quoted Rate should be inclusive of all Labour charges and applicable Taxes.
10. During evaluation of the credentials as well as the Quotations submitted by the Bidders, the Authority may at its discretion ask for clarifications from the Bidders.
11. The right to reject the lowest or all Quotations without assigning any reason thereof is kept reserved by the competent Authority of The WBSCARD Bank Ltd.
12. The Bidder should append a **Certificate** with the Bid that the Firm/Agency has not been debarred/blacklisted for any reason/period by any Central/State Govt. Dept./University/PSU, etc. If so, particulars of the same may be furnished. Concealment of facts shall lead to cancellation of the Order.
13. Prospective Bidders/Agencies may visit the location/site for getting detailed positions of the AC Machines and for proper understanding of other Scope of Works before submitting the Quotations. The List of Equipment is mentioned in **Annexure – I** (attached herewith).
14. The Authority of The WBSCARD Bank Ltd. reserves the right to accept or reject any or all Bids at any time prior to placement of Order without assigning any reason thereto and without any obligation to inform the affected Bidders.

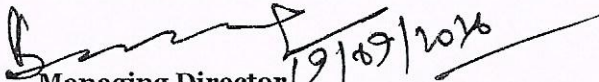
