I. Site Survey & Assessment: -

- Conducting a physical inspection of the Rooftops to identify available shadow-free areas.
- Assessing the structural integrity and load-bearing capacity of the Roofs for installing Solar Modules and Mounting Structures.
- Assessing the existing Electrical Infrastructure (Transformers, LT/HT Panels, Sanctioned Load, current Electricity Bills, DG Sets) to determine the feasibility of Grid-Connected / Net-Metering / Net-Billing Systems.

II. Preparation of Drawings: -
